Bethel Presbyterian Weekday Preschool Registration 2012-2013

Registration for all Bethel Presbyterian Church members and currently enrolled students:

- Submit a registration form- either attached or found at our website: <http://www.bethel-pc.org> for each child you plan to enroll. Include a \$75/child non-refundable fee. Send only ONE check made out to BPC Weekday Preschool for the total number of applicants.
- Registration will be accepted February 1-15, 2012 for all church members and currently enrolled students and their siblings.
- An e-mail confirming your child's acceptance into the preschool will be sent out by February 15th. Should the class be filled, registration money will be returned to you. A priority list will then be established.

Registration for the general public:

- Registration forms for new students will be available for pick-up from the preschool or church office February 1st-17th from 9:15AM-1PM. You can also download additional applications from the website: <http://www.bethel-pc.org> Enclose one form/child.
- Complete and return the registration form to the preschool. No money is required until a space is guaranteed in the program.
- A lottery to fill the remaining slots in the preschool will be conducted on Friday, February 17th.
- You will be notified via e-mail if you have been selected. You have one week to submit the \$75 application fee to secure your slot.
- All other applicants will be placed on a waiting list and notified upon availability.

General Information

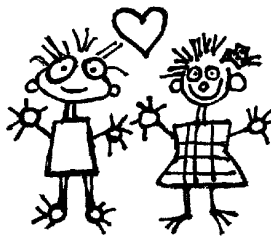
- Be certain to indicate class preference and child's birth date. All children must be the age of their particular class by August 31, 2012.
- An annual \$85/child material fee is due by the first day of school. This fee covers the cost for crafts and disposable products.
- All three and four year olds must be toilet trained.
- Hours of operation 9:15AM-1PM with lunch bunch held every day. Parents provide lunch for their child.
First tuition payment is due May 1st. This payment is NON-REFUNDABLE.

The Preschool Board has authorized several new options for the 2012-13 school year:

- Parents of a two year old can purchase Friday classes for an additional fee. This is a year -long commitment. It will be a first come first serve basis. Once the 11 slots are filled your child will be placed on a waiting list for Fridays.
- Parents of three year olds have the option of either a three day/week class (Monday/Wednesday/Thursday) or a four day/week class (Monday through Thursday).
- All four year olds will meet M-TH; however, an enrichment class will be offered on Fridays. The "Fun Fridays" will have additional science experiments, cooking projects, literature, and theatre. The class is a first come first serve basis and a year- long commitment. Once the class is filled your child will be placed on a waiting list.
